If you have **pending financial aid** of S.C. Need-Based Grant or LIFE Scholarship, you are required to sign a certification to receive the funds. Please stop by Financial Aid/Enrollment Services in the Student Services Building to complete the required form(s) or download the form(s) from WebAdvisor under Student Forms. If the certification is not signed in a timely manner, you may lose your award. If you have **estimated financial aid**, it must be accepted in WebAdvisor. We recommend that you accept all aid for the entire award year. If you need assistance, please come by Financial Aid/Enrollment Services.

**When Can I Go To The Bookstore To Purchase Books?**

Bookstore purchases are allowed each semester prior to the first day of class and continuing two weeks after classes begin. You will need your schedule and ID to make charges to your account. You may also opt-out of purchasing your books on campus with financial aid by notifying Financial Aid/Enrollment Services three weeks prior to the start date of the semester.

**How Do I Get My FA Refund?**

If you have a balance remaining after your tuition, fees, book and/or supply expenses have been deducted, your refund will be available on your Higher One debit card **no later than four weeks after the semester begins**.

**Return of Federal Financial Aid (Title IV) Funds Policy**

Your federal financial aid eligibility must be recalculated if you completely withdraw, drop out, or are dismissed prior to completing 60% of a session. The calculation is based on the last date of attendance reported by the instructors in each class. You must attend after the following dates in order to complete 60% of the session.
